**The Approved Warehouses (Bailiwick of Guernsey)  
(Amendment) Order, 2015**

THE HOME DEPARTMENT, in exercise of the powers conferred on it by sections 41 and 79 of the Customs and Excise (General Provisions) (Bailiwick of Guernsey) Law, 1972<sup>a</sup>, hereby orders:-

**Amendment of the 2012 Order.**

1. In Schedule 1 to the Approved Warehouses (Bailiwick of Guernsey) Order, 2012<sup>b</sup>, in row No. 6, for "Specified premises at Fort Road Garage, Fort Road, St Peter Port, Guernsey", substitute "Specified premises within the 7Day Self Store, Pitronnerie Road, St Peter Port, Guernsey".

**Interpretation.**

2. (1) In this Order, unless the context requires otherwise –

"enactment" means any Law, Ordinance or subordinate legislation,  
and

"subordinate legislation" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect.

(2) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Citation and commencement.**

3. This Order may be cited as the Approved Warehouses (Bailiwick of Guernsey) (Amendment) Order, 2015 and shall come into force on the 7<sup>th</sup> July, 2015.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends the Approved Warehouses (Bailiwick of Guernsey) Order, 2012 by substituting premises specified by the Chief Officer of Customs and Excise at Fort Road Garage, Fort Road, St Peter Port, Guernsey, in relation to E A Carey (Europe) Limited, with premises so specified within the 7Day Self Store, Pitronnerie Road, St Peter Port, Guernsey.

These latter premises will be an approved warehouse where dutiable goods may be deposited and held without payment of excise duty.

This Order comes into force on the 7<sup>th</sup> day of July, 2015.
