

The Parking Places (Amendment) (No.2) Order, 2015

Made

25th August, 2015

Coming into operation

1st September, 2015

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended^a, hereby orders:-

1. The Parking Places Order, 1991, as amended^b, is further amended as follows.
2. In Article 9(h)(ii), for "DH2, DH2a, DH3, DH4 or DH5" substitute "DH2, DH3 or DH4".
3. In Part A of Schedule 1, in the third column relating to Disc Parking Place No. DA1, the words ", but excluding Approved Parking Place No. AE3 from 15th March to 15th October inclusive" are deleted.
4. In Part B of Schedule 1, in the third column relating to Disc Parking Place No. DB24, the words ", and Disc Parking Place No. DH5" are deleted.
5. In Part C of Schedule 1, in the third column relating to Disc Parking Place No. DC37, for the words, "Place No. AB16" substitute ", Places Nos. AB16 and AC73".

6. In Part C of Schedule 1, immediately following the entry relating to Disc Parking Place No. DC51 insert the following entry –

"DC52	Route Isabelle	The south side of the portion of the road from a point 40m to the east of its junction with Route Isabelle to the access to Le Foulon Cemetery."

7. In Part D of Schedule 1, in the third column relating to Disc Parking Place No. DD14, the words "but excluding Approved Parking Place No. AC57" are deleted.

8. In Part H of Schedule 1, delete the entries relating to Disc Parking Place Nos. DH2a and DH5.

9. In Part A of Schedule 2, immediately following the entry relating to Approved Parking Place No. AA6 insert the following entry -

"AA6a	Route Isabelle	The south side of the portion of the road from a point 55m to the west of its junction with York Avenue to a point 10m to the east of the access to Le Foulon Cemetery."

10. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA23, the words ", but excluding Approved Parking Place No. AC42" are deleted.

11. In Part A of Schedule 2, the entry in the third column relating to Approved Parking Place No. AA80, is deleted and the words "The north side of the road between a point 30m to the north east of the junction with Quay Street and the junction with Pier Steps, but excluding Approved Parking Place No. AD3." are inserted.

12. In Part A of Schedule 2, immediately following the entry relating to Approved Parking Place No. AA90 insert the following entries -

"AA91	Avenue Beauvais	Both sides of the road
AA92	Avenue Germain	Both sides of the road, but excluding Approved Parking Place No. AC64
AA93	Avenue Du Manoir	Both sides of the road, but excluding Approved Parking Place No. AC51
AA94	Avenue Vivier	Both sides of the road, but excluding Approved Parking Place No. AC71."

13. In Part B of Schedule 2, delete the entry relating to Approved Parking Place No. AB22c.

14. In Part C of Schedule 2, in the third column relating to Approved Parking Place No. AC9, for the words "at the north end of the road" substitute "immediately to the north of the junction with Bridge Avenue,".

15. In Part C of Schedule 2, delete the entries relating to Approved Parking Place Nos. AC42 and AC57.

16. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC72 insert the following entry –

"AC73	Les Canichers	The portion of the west side of the road, as near as practical to the property known as No. 44, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

17. In Part E of Schedule 2, delete the entry relating to Approved Parking Place No. AE3.

18. This Order may be cited as the Parking Places (Amendment) (No. 2) Order, 2015.

19. This Order shall come into force on the 1st September, 2015.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991, as amended. It allocates a new disabled bay in approved parking place No. AC73 (Les Canichers as further specified in this Order), removes disabled bays in approved parking place Nos. AC42 and AC57 (Les Amballes and Mount Hermon as further specified in this Order), removes motor bicycle parking in approved parking places No. AB22c (The Bridge, Saint Sampson as further specified in this Order), removes unloading bays alternating as disc parking places in approved parking place Nos. DH2a and DH5 (both at The Bridge as further specified in this Order) (the Environment Department will replace these spaces with permanent unloading bays), introduces 2-hour approved parking at Route Isabelle, 23-hour approved parking at Avenue Beauvais and Avenue Vivier, additional 23-hour approved parking at Route Isabelle, Avenue Germain and Avenue Du Manoir (as further specified in this Order), and removes the approved parking place for buses No. AE3 (South Esplanade as further specified in this Order).

This Order comes into force on the 1st day of September, 2015.
