

The Parking Places (Amendment) (No.4) Order, 2015

10th December, 2015

Coming into operation

7th December, 2015

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended^a, hereby orders:-

1. The Parking Places Order, 1991, as amended^b, is further amended as follows.

2. In Part C of Schedule 1, in the third column relating to Disc Parking Place No. DC2, the words "but excluding Approved Parking Place No. AB6" are deleted.

3. In Part C of Schedule 1, in the third column relating to Disc Parking Place No. DC15, immediately following the words "The east side of the road" insert, "but excluding Approved Parking Place No. AC74".

4. In Part E of Schedule 1, in the third column relating to Disc Parking Place No. DE1, the words "but excluding Approved Parking Place No. AB6" are deleted.

5. In Part E of Schedule 1, in the third column relating to Disc Parking Place No. DE2, immediately following the words "of the Horseshoe Pool" insert, "but excluding Approved Parking Place No. AB6".

6. In Part E of Schedule 1, in the third column relating to Disc Parking Place No. DE28, immediately following the words "Paris Street and Piette Road" insert, "but excluding Approved Parking Place No. AC31".

7. In Part B of Schedule 2, the entry in the third column relating to Approved Parking Place No. AB6, is deleted and the words "On the seaward side of the road immediately to the north of the rock outcrop to the south of the Horseshoe Pool" are inserted.

8. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC73, insert the following entry –

"AC74	St John's Street	The east side of the road, as near as practicable to the property known as No. 12, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge"

9. This Order may be cited as the Parking Places (Amendment) (No. 4) Order, 2015.

10. This Order shall come into force on the 7th December, 2015.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991, as amended. It re-locates a motorcycle parking bay at La Valette to a more northerly position following a successful trial period, and it allocates an additional disabled person bay No. AC74 in St John's Street, St Peter Port.

This Order comes into force on the 1st day of December, 2015.
