## **The Veterinary Surgery and Animal Welfare (Alderney) Ordinance, 1994**

**THE STATES OF ALDERNEY**, in pursuance of their Resolution of the 7<sup>th</sup> day of December, 1994, and in exercise of the powers conferred upon them by section 46 of the Government of Alderney Law, 1987<sup>a</sup>, hereby order: –

### **Provisions of Guernsey Ordinance to have effect in Alderney.**

1. The provisions of the Veterinary Surgery and Animal Welfare Ordinance, 1987, as amended<sup>b</sup>, shall apply in Alderney subject to the modifications set out in section 2; and accordingly the provisions of that Ordinance, as so modified, shall have effect in Alderney in all respects as an Ordinance of the States of Alderney.

### **Modifications to Guernsey Ordinance.**

2. The modifications to the provisions of the Veterinary Surgery and Animal Welfare Ordinance, 1987 referred to in section 1 are as follows –

- (a) in sections 8(1)(b), 9, 10(1) and (2), 12, 14(1)(a) and 22(a) for "the Register of Veterinary Surgeons" substitute "the Alderney Register of Veterinary Surgeons",
- (b) in sections 9, 10(1) and (2), 11, 12, 14(1), 18, 19 and 22(a) for "the Board" substitute "the Committee",
- (c) delete section 13,
- (d) in section 14(1) for "Her Majesty's Greffier"

substitute "the Clerk of the States",

(e) for section 14(2) substitute –

"(2) The information provided under subsection (1) shall be available at the Clerk's office for public inspection free of charge whenever the said office is open for business.",

(f) in section 16(f) for the words from "a person authorised" to "the 1951 Ordinance" (both expressions inclusive) substitute "a recognised medical practitioner",

(g) in section 16(g) for the words from "a person authorised" to "the 1951 Ordinance" (both expressions inclusive) substitute "a recognised dentist",

(h) in section 20 for "the Protection of Animals Ordinance, 1976" substitute "the Protection of Animals Ordinance, 1977<sup>c</sup>",

(i) in section 21(1) for paragraphs (a) and (b) substitute "on conviction to a fine not exceeding level 4 on the Alderney uniform scale, 3 months imprisonment or both",

(j) in section 21(2) for £500 substitute "level 4 on the Alderney uniform scale",

(k) in section 22(a) for the definition of "the Board" substitute –

**"the Committee"** means the [General Services] Committee",

- (l) in section 22(a) delete the definition of "the 1951 Ordinance",
- (m) delete section 23,
- (n) in section 24 for the words "Guernsey, whether reference is made to the 1951 Ordinance or not" substitute "Alderney",
- (o) delete section 25.
