**THE POLICY COUNCIL**, in exercise of the powers conferred on it by sections 49A and 54 of the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendment of regulations.**

1. In regulation 16 of the Criminal Justice (Proceeds of Crime) (Legal Professionals, Accountants and Estate Agents) (Bailiwick of Guernsey) Regulations, 2008<sup>b</sup> -

- (a) in paragraph (2)(b) for "£612" substitute "£624",
- (b) in paragraph (2)(b)(i) -

- (i) for "£93" substitute "£95",
- (ii) for "£465" substitute "£474", and
- (c) in paragraph (2)(b)(ii) for "£1,860" substitute "£1,900".

**Repeal.**

2. The Criminal Justice (Proceeds of Crime) (Legal Professionals, Accountants and Estate Agents) (Bailiwick of Guernsey) (Amendment) (No. 2) Regulations, 2014<sup>c</sup> are repealed.

**Interpretation.**

3. (1) The Interpretation (Guernsey) Law, 1948<sup>d</sup> applies to the interpretation of these Regulations.

(2) Any reference in these Regulations to an enactment or statutory instrument is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Citation.**

4. These Regulations may be cited as the Criminal Justice (Proceeds of Crime) (Legal Professionals, Accountants and Estate Agents) (Bailiwick of Guernsey) (Amendment) Regulations, 2015.

**Commencement.**

5. These Regulations shall come into force on the 1<sup>st</sup> January, 2016.

EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations update the fees payable by prescribed businesses under the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999.

These Regulations come into force on the 1<sup>st</sup> January, 2016.
