

## The Boarding Permit Fees Order, 2016

<i>Made</i>	<i>21<sup>st</sup> January 2016</i>
<i>Coming into operation</i>	<i>1<sup>st</sup> April, 2016</i>
<i>Laid before the States</i>	<i>2016</i>

**THE COMMERCE AND EMPLOYMENT DEPARTMENT**, in exercise of the powers conferred on it by section 17 of the Tourist Law, 1948<sup>a</sup> as amended<sup>b</sup> and all other powers enabling it in that behalf, hereby orders:-

**Fee payable by applicants for a boarding permit.**

1. An applicant for a boarding permit shall pay to the Department on application for a permit valid from 1<sup>st</sup> April 2016 to 31<sup>st</sup> March 2017, or part thereof, a fee of £8.50 multiplied by the maximum number of persons for whom the applicant seeks permission to provide sleeping accommodation for reward.

**Interpretation.**

2. (1) In this Order, unless the context requires otherwise –
- (a) “**the Law**” means the Tourist Law, 1948; and
  - (b) “**Department**” means the Commerce and Employment Department.

(2) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of this Order.

3. The Boarding Permit Fees Order, 2015 is repealed. <sup>d</sup>


**Citation.**
