

**The Driving Tests (Fees) Regulations, 2016***Made*4<sup>th</sup> February, 2016*Coming into operation*8<sup>th</sup> February, 2016*Laid before the States*

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred on it by sections 2A(b) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987<sup>a</sup>, as amended and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendments to the 1995 Ordinance.**

1. For Schedule 2 to the Driving Licences (Guernsey) Ordinance, 1995, as amended<sup>b</sup> (the "Ordinance"), substitute -

The fee payable prior to taking a test of competence relating to a motor vehicle of a class included in the category set out in column (1) of the Table below shall be the corresponding sum set out in column (2) thereof.

**Interpretation.**

2. (1) In these Regulations, unless the context requires otherwise –

"**enactment**" means any Law, Ordinance or subordinate legislation,

"**the Ordinance**" : see regulation 1, and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect.

(2) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Revocation.**

3. The Driving Licences and Driving Tests (Fees) Regulations, 2015<sup>d</sup> are revoked.

**Extent.**

4. These Regulations have effect in the Islands of Guernsey and Alderney.

**Citation.**

5. These Regulations may be cited as the Driving Tests (Fees) Regulations, 2016.

**Commencement and application.**

6. These Regulations shall come into force on the 8<sup>th</sup> February, 2016 and shall apply in respect of tests of competence which take place on or after the 18<sup>th</sup> April, 2016.
