The Parking Places (Amendment) (No.2) Order, 2016

Made

March, 2016

Coming into operation

1st April, 2016

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended^a, hereby orders:-

1. The Parking Places Order, 1991, as amended^b, is further amended as follows.
2. In Part B of Schedule 1, in the third column relating to Disc Parking Place No. DB14, for "and AB20" substitute ", AB20 and AC77".
3. In Part D of Schedule 1, in the third column relating to Disc Parking Place No. DD14, immediately following the words "Both sides of the road" insert, "but excluding Approved Parking Place No. AC75".
4. In Part E of Schedule 1, in the third column relating to Disc Parking Place No. DE26, immediately following the words "The north-west side of the road" insert, "but excluding Approved Parking Place No. AC76".
5. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC74 insert the following entries -

"AC75	Mount Hermon	The south side of the road adjacent to its junction with Victoria Road within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC76	Piette Road	The western side of the road as near as possible to the property known as Fiere D'meure within the limits as indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC77	Ville au Roi	The north western side of the parking area adjacent to its junction with Ruelle Braye within the limits as indicated by signs as being reserved for persons in possession of a disabled person's badge."

6. This Order may be cited as the Parking Places (Amendment) (No. 2) Order, 2016

7. This Order shall come into force on the 1st April, 2016.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991, as amended. It allocates new disabled bays in approved parking places Nos. AC75, AC76 and AC77 (Mount Hermon, Piette Road and Ville au Roi car park respectively as further specified in this Order).

This Order comes into force on the 1st day of April, 2016.
