

The Driving Licences (Amendment) Regulations, 2016*Made*28th April, 2016*Coming into operation*3rd May, 2016*Laid before the States*

, 2016

THE ENVIRONMENT DEPARTMENT, in exercise of the powers conferred on it by sections 2A(a) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987^a, hereby makes the following Regulations:-

Amendment of 1995 Ordinance.

1. The Driving Licences (Guernsey) Ordinance, 1995^b, is further amended as follows.

2. In Category D (Large passenger-carrying vehicle) of Schedule 4 (Categories of Licence) of the Driving Licences (Guernsey) Ordinance, 1995 –

- (a) in the heading, after "vehicle" insert "including a *petit train*",
- (b) in the first paragraph, after "750 kilograms" insert "OR",

- (c) in the first paragraph, delete the full stop, and
- (d) immediately beneath the first paragraph insert the following paragraph –

"A combination of vehicles forming a road train vehicle consisting of up to three trailers or carriages constructed or adapted to carry passengers towed or propelled by a motor vehicle with a maximum authorised mass not exceeding 7,500kg and used or intended to be used to operate a low speed road train public excursion service or private hire omnibus service under the Public Transport Ordinance, 1986."

Interpretation.

3. (1) In these Regulations, unless the context requires otherwise -

"**enactment**" means any Law, Ordinance or subordinate legislation, and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect.

- (2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation and commencement.

4. These Regulations may be cited as the Driving Licences

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Driving Licences (Guernsey) Ordinance, 1995 to clarify that a road train comes within Category D (Large passenger-carrying vehicle) of the categories of licence set out under Schedule 4 of the Ordinance.

These Regulations come into force on the 3rd day of May, 2016.
