# **The Shorthand Notes and Transcripts (Criminal Cases) (Guernsey) (Amendment) Rules, 2016**

**THE ROYAL COURT**, in exercise of the powers conferred upon it by Section 41(2) of the Court of Appeal (Guernsey) Law, 1961<sup>a</sup>, hereby orders:-

## **Amendment to the 1964 Rules.**

1. In Rule 5A of the Shorthand Notes and Transcripts (Criminal Cases) (Guernsey) Rules, 1964<sup>b</sup>, for "£50" substitute "£52", and for "£30" substitute "£32".

## **Interpretation.**

2. (1) In these Rules, unless the context requires otherwise -

**"enactment"** means any Law, Ordinance or subordinate legislation, and

**"subordinate legislation"** means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect,

(2) Any reference in these Rules to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

4. These Rules shall come into force on the 1<sup>st</sup> January, 2017.
