**The Public Records (Fees for Registration and Certified
Copies of Documents) Regulations, 2016**

Made , 2016
Coming into operation 1st January, 2017
Laid before the States , 2017

THE POLICY & RESOURCES COMMITTEE, in exercise of the powers conferred on it by sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^a as amended, and all other powers enabling it in that behalf, hereby makes the following regulations:-

Registration fees for documents.

1. In section 1 of the Public Records (Fees for Registration and Certified Copies of Documents) Ordinance, 1960^b ("**the 1960 Ordinance**") -

- (a) in paragraph (a), for "£60" substitute "£63", and
- (b) in paragraphs (b) and (c), for "£5.00" substitute "£5.50".

Fees for certified copies of documents.

2. In section 2 of the 1960 Ordinance -
 - (a) in paragraph (a), for "£3.50" substitute "£4.00", and
 - (b) in paragraph (b), for "£5.50" substitute "£6.00".

Fees for uncertified copies of registered documents.

3. In section 2A of the 1960 Ordinance -
 - (a) in paragraphs (a) and (b)(ii), for "£2.00" substitute "£2.50", and
 - (b) in paragraph (b)(i), for "£4.50" substitute "£5.00".

Fees in respect of documents creating charge on land.

4. In paragraphs (a) and (b) of section 2B of the 1960 Ordinance, for "£50" substitute "£53".

Interpretation.

5. (1) In these Regulations, unless the context requires otherwise -

"**enactment**" means any Law, Ordinance or subordinate legislation,
and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect,

- (2) Any reference in these Regulations to an enactment is a

reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

(3) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these Regulations.

Repeal.

6. The Public Records (Fees for Registration and Certified Copies of Documents) Regulations, 2014^d are repealed.

Citation.

7. These Regulations may be cited as the Public Records (Fees for Registration and Certified Copies of Documents) Regulations, 2016.

Commencement.

8. These Regulations shall come into force on 1st January, 2017.
