

The Parking Places (Amendment) (No. 5) Order, 2016

Made

12th December, 2016

Coming into operation

31st December, 2016

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963^a, hereby orders:-

Amendments to 1991 Order.

1. The Parking Places Order, 1991, as amended^b, is further amended as follows.

2. In Part D of Schedule 1 -

(a) in the first column of the entry immediately following that relating to disc parking place No. DD17, for "DC18" substitute "DD18", and

(b) in the third column of the entry relating to disc parking place No. DD19, immediately following the words "St Julian's Avenue," insert "within the limits indicated by signs as being reserved for vehicles not exceeding 3.6m long by 1.7m wide,".

3. In Part A of Schedule 2 -

(a) in the third column of the entry relating to approved parking place No. AA20, for the words "Both sides" substitute "The western side",

- (b) in the third column of the entry relating to approved parking place No. AA42, immediately following the words "Clairval Estate" insert ", but excluding approved parking place No. AC82", and
- (c) in the third column of the entry relating to approved parking place No. AA62, immediately following the words "of the estates" insert ", but excluding approved parking place no. AC83".

4. In Part C of Schedule 2 -

- (a) delete the entry relating to approved parking place No. AC5f, and
- (b) immediately following the entry relating to approved parking place No. AC81, insert the following additional entries -

"AC82	Valnord Estate	The portion of the north side of the road, as near as practicable to No. 8, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC83	Courtil Portier	The portion of the north west side of the road, as near as practicable to No. 4, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

Repeal.

5. Article 15 of the Parking Places (Amendment) (No.4) Order, 2016^c is repealed and the amendment to Part D of Schedule 2 purported to be made thereby is of no effect.

Interpretation.

6. (1) In this Order, unless the context requires otherwise -

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation, and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance.

(2) The Interpretation (Guernsey) Law, 1948^d applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation and commencement.

7. This Order may be cited as the Parking Places (Amendment) (No. 5) Order, 2016 and shall come into force on the December, 2016.

EXPLANATORY NOTE
(This note is not part of the Order)

This Order amends the Parking Places Order, 1991, as amended. It allocates new disabled parking bays at Valnord Estate and Courtil Portier in the existing 23-hour approved parking spaces at the request of disabled badge holders. It also removes a disabled parking bay from Clairval Estate where it is no longer required.

It also rectifies a minor error in a previous amendment relating to size-restricted parking in Candie Road and corrects a minor error in the identification number of a parking zone number in Schedule 1, Part D relating to Upland Road and makes a minor change to parking in Amherst Road, where one parking bay from the eastern side of the road has been removed because of a development and creation of a new access.

This Order comes into force on the 31st December, 2016.
