The Driving Tests (Fees) Regulations, 2017

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by sections 2A(b) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987^a, as amended and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendments to the 1995 Ordinance.

1. For Schedule 2 to the Driving Licences (Guernsey) Ordinance, 1995, as amended^b (the "Ordinance"), substitute -

DRIVING TEST FEES

The fee payable prior to taking a test of competence relating to a motor vehicle of a class included in the category set out in column (1) of the Table below shall be the corresponding sum set out in column (2) thereof.

Interpretation.

2. (1) In these Regulations, unless the context requires otherwise –

"enactment" means any Law, Ordinance or subordinate legislation,

"the Ordinance" : see regulation 1, and

"subordinate legislation" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect but does not include an Ordinance.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Revocation.

3. The Driving Tests (Fees) Regulations, 2016^d are revoked.

Extent.

4. These Regulations have effect in the Islands of Guernsey and Alderney.

Citation.

5. These Regulations may be cited as the Driving Tests (Fees) Regulations, 2017.

Commencement and application.

6. These Regulations shall come into force on the 17th February, 2017 and shall apply in respect of tests of competence which take place on or after the 1st April, 2017.
