The Boarding Permit Fees Order, 2017

THE COMMITTEE *for* ECONOMIC DEVELOPMENT, in exercise of the powers conferred on it by section 17 of the Tourist Law, 1948^a as amended^b and all other powers enabling it in that behalf, hereby orders:-

Fee payable by applicants for a boarding permit.

1. An applicant for a boarding permit shall pay to the Committee on application for a permit valid from 1st April 2017 to 31st March 2018, or part thereof, a fee according to the type and nature of the premises within which the accommodation is to be provided:

- a) For serviced visitor accommodation provided in premises with a use classification under schedule 1 of **The Land Planning and Development (Use Classes) Ordinance, 2017** as visitor accommodation use class 7; the sum of £15-00 per permit application submitted.

- b) For non-serviced visitor accommodation provided in premises with a use classification under schedule 1 of **The Land Planning and Development (Use Classes) Ordinance, 2017** as visitor accommodation use class 8: the sum of £15-00 per permit application submitted.

- c) For visitor accommodation provided in premises classified as residential (use classes 1, 2, 5 & 6 only), under schedule 1 of **The**

Land Planning and Development (Use Classes) Ordinance, 2017,
the sum of £50-00 per permit application submitted.

Interpretation.

2. (1) In this Order, unless the context requires otherwise ¥
- (a) ~~±the Law~~ means the Tourist Law, 1948; and
- (b) ~~±Committee~~ means the Committee *for* Economic Development.
- (2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of this Order.
- (3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Repeal.

3. The Boarding Permit Fees Order, 2016 is repealed. ^d

Citation.

4. This Order may be cited as the Boarding Permit Fees Order, 2017.

Commencement.

5. This Order comes into force on the 1st April, 2017.
