THE POLICY AND RESOURCES COMMITTEE, in exercise of the powers conferred on it by section 3 of the Terrorism and Crime (Bailiwick of Guernsey) Law, 2002^a and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Proscribed Organisations.

1. The following organisations are hereby added to Schedule 1 to the Terrorism and Crime (Bailiwick of Guernsey) Law, 2002 (“the 2002 Law”):-

2. The following organisations are hereby deleted from Schedule 1 to the
2002 Law:-

3. For "Hizballah External Security Organisation" in Schedule 1 to the
2002 Law, substitute "The military wing of Hizballah, including the Jihad Council
and all units reporting to it (including the Hizballah External Security
Organisation)".

Interpretation.

4. (1) The Interpretation (Guernsey) Law, 1948^b applies to the
interpretation of these Regulations.

(2) Any reference in these Regulations to an enactment is a

reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation and commencement.

5. These Regulations may be cited as the Terrorism and Crime (Bailiwick of Guernsey) Law, 2002 (Proscribed Organisations) (Amendment) Regulations, 2017 and shall come into force on the...., 2017.

EXPLANATORY NOTE

These Regulations amend the list of organisations that are proscribed for the purposes of the Terrorism and Crime (Bailiwick of Guernsey) Law 2002. The amendments have been made so that the list of proscribed organisations mirrors that applicable in the United Kingdom under the Terrorism Act 2000.

These Regulations come into force on the 28th day of February, 2017.
