The Parking Places (Amendment) Order, 2017

Coming into operation

13th March, 2017

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963^a, hereby orders:-

Amendments to 1991 Order.

1. The Parking Places Order, 1991^b, is amended as follows.
2. In Part C of Schedule 1, in the third column of the entry relating to Disc Parking Place No. DC22, immediately following the words "Vale Road", insert "within the limits indicated by signs".
3. In Part E of Schedule 1, immediately following the entry relating to disc parking place No. DE34, insert the following additional entry -

"DE35	Les Banques, Saint Sampson	The west side of the portion of the road between the junctions with the road leading to Belgrave outfall and Vale Road within limits indicated by signs."

4. In Part A of Schedule 2 –

- (a) in the third column of the entry relating to Approved Parking Place No AA10, immediately following the words "St. Stephens Lane", insert ", but excluding Approved Parking Place No AC84",
- (b) in the third column of the entry relating to Approved Parking Place No AA13, immediately following the words "indicated by signs", insert ", but excluding Approved Parking Place No AA13a",
- (c) immediately following the entry relating to Approved Parking Place No. AA13, insert the following additional entry –

"AA13a	Dalgairns Road	The east side of the portion of the road opposite a house called St Aubyns within the limits indicated by signs as being reserved for vehicles not exceeding 3.7m long by 1.7m wide."

5. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC83, insert the following additional entry –

"AC84	Les Croutes	The north west side of the portion of the road between the junctions with Les Gravees and St. Stephens Lane, within limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

Interpretation.

6. (1) In this Order, unless the context requires otherwise -

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation, and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation and commencement.

7. This Order may be cited as the Parking Places (Amendment) Order, 2017 and shall come into force on the 13th March, 2017.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order further amends the Parking Places Order, 1991. It removes eleven 2-hour spaces along three sections of Les Banques and replaces them with eleven 10-hour spaces. This results from a number of surveys which highlighted the significant underuse of the 2-hour spaces.

It also creates a new disabled bay at Les Croutes (also known as St Stephen's Hill) in the existing 23-hour Approved Parking spaces.

The Order further introduces two small car parking bays in the 23 hour Approved Parking section of Dalgairns Road, as reserved for vehicles not exceeding 1.83m wide.

This Order comes into force on the 13th March, 2017.
