**TELEVISION AND LOCAL SOUND BROADCASTING**

**The Sound Broadcasting Act 1972 (Channel Islands) Order 1973**

*Made* - - - - - 20th June 1973

*Coming into Operation* 16th July 1973

At the Court at Windsor Castle, the 20th day of June 1973

Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, in exercise of the powers conferred on Her by section 13(5) of the Sound Broadcasting Act 1972(a), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1. This Order may be cited as the Sound Broadcasting Act 1972 (Channel Islands) Order 1973 and shall come into operation on 16th July 1973.

2. Sections 1, 4, 6, 12 and 13 of, and Schedules 1 and 2 to, the Sound Broadcasting Act 1972 shall extend to the Channel Islands subject to the exceptions, adaptations and modifications specified in the Schedule to this Order.

SCHEDULE

EXCEPTIONS, ADAPTATIONS AND MODIFICATIONS IN THE EXTENSION OF PARTS OF THE SOUND BROADCASTING ACT 1972 TO THE CHANNEL ISLANDS

1. Unless the context otherwise requires, any reference to the Sound Broadcasting Act 1972, shall be construed as a reference to that Act as extended to the Channel Islands by this Order and any reference to the Television Act 1964(b) (hereinafter referred to as "the Act of 1964") shall be construed as a reference to that Act as extended to the Channel Islands by the Television Act 1964 (Channel Islands) Order 1964(c) as amended by the Television Act 1964 (Channel Islands) Order 1969(d).

2. Any reference in the Sound Broadcasting Act 1972 to local sound broadcasting shall be construed as local sound broadcasting provided or to be provided by the Authority in the United Kingdom by virtue of the aforesaid Act as it has effect in the United Kingdom.

3. In section 6, subsections (3) and (4) and in subsection (1) the words "or subsection (3A)" shall be omitted.
  4. In section 13, subsections (4), (5) and (6) shall be omitted.
  5. Schedule 1 shall apply only in respect of sections 1, 13, 21 and 28 of the Act of 1964 and to Schedule 1 thereto and—
    - (a) in the amendment of section 1 for the first semicolon there shall be substituted a full stop and all the following words shall be omitted;
    - (b) in the amendment of section 13 there shall be omitted the words "In subsection (1)," and the words "in paragraph (a),";
    - (c) in the amendment of section 28 all the words between "In subsection (1)," and "after the definition" shall be omitted and after the words "Sound Broadcasting Act 1972" in both places where they occur, there shall be inserted the words "as it has effect in the United Kingdom".
  6. Schedule 2 shall apply only in respect of the repeal of subsections (1) and (2) of section 21 of the Act of 1964.
