The Parking Places (Amendment) (No. 2) Order, 2017

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963^a, hereby orders:-

Amendments to 1991 Order.

1. The Parking Places Order, 1991^b is amended as follows.
2. In Part B of Schedule 1, in the third column of the entry relating to disc parking place No. DB6, insert the additional words "but excluding Approved Parking Place No. AC85".
3. In Part E of Schedule 1, in the entry relating to North Quay, Vale, for "DE35" substitute "DE35A".
4. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC84, insert the following additional entry -

"AC85	Victoria Road	The portion of the south side of the road, as near as practicable to No. 29, indicated by signs as being reserved for persons in possession of a disabled person's badge."

Interpretation.

5. (1) In this Order, unless the context requires otherwise -

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation,

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance..

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation and commencement.

6. This Order may be cited as the Parking Places (Amendment No. 2) Order, 2017 and shall come into force on the 7th August, 2017.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991. It replaces a one-hour disc parking place in Victoria Road, St Peter Port with an approved parking place reserved for persons in possession of a disabled person's badge. It also amends a typographical error in Part E of Schedule 1.

This Order comes into force on the 7th day of August, 2017.
