The Parking Places (Amendment) (No. 3) Order, 2017

Coming into operation

24th September, 2017

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963^a, hereby orders:-

Amendments to 1991 Order.

1. The Parking Places Order, 1991^b is amended as follows.
2. In Article 19 -
 - (a) in the definition of "**Bank Holiday**", for "Bank Holiday" (in the second place where it occurs) substitute "Public Holiday", and
 - (b) immediately following the definition of "**private hire motor car licence**", insert -

""Public Holiday" means a day approved as a Public Holiday by Ordinance,".

3. In Part C of Schedule 1 -

(a) immediately following the entry relating to disc parking place No. DC16, insert the following additional entry -

"DC16a	Hospital Lane	The portion at the eastern end of the south side of the road indicated by signs as being reserved for persons in possession of a disabled person's badge.

and

(b) in the third column of the entry relating to disc parking place No. DC17, substitute for the existing text "The north-east corner of Hirzel Street and the south side of the portion of Hospital Lane between Approved Parking Place No. AA96 and Approved Parking Place No. AA81a, but excluding the area on which bicycle racks are situated.".

4. In Part A of Schedule 2, immediately following the entry relating to approved parking place No. AA81, insert the following additional entry -

AA81a	Hospital Lane	The portion of the south side of the road indicated by signs as being reserved for callers to

5. In Part C of Schedule 2, the entry relating to approved parking place No. AC4 is revoked.

6. In Part D of Schedule 2, in the third column of the entry relating to approved parking place No. AD6, the words "but excluding Approved Parking Place No. AC4 between 09.00 and 17.00 Monday to Saturday" are revoked.

Interpretation.

7. (1) In this Order, unless the context requires otherwise -

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation,

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance..

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference



Citation and commencement.

8. This Order may be cited as the Parking Places (Amendment No. 3) Order, 2017 and shall come into force on the 24th September, 2017.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991. It increases the provision for callers to Edward T. Wheadon House by replacing 3 2-hour disc parking places in Hospital Lane with approved parking spaces reserved for callers to Edward T. Wheadon House on Monday to Friday between the hours of 8.30 am to 4.30 pm except on public holidays. The Order also replaces a disabled parking space at Gategny Esplanade with an approved parking place reserved for taxis and creates a new disabled parking space, with a 2-hour time limit, in Hospital Lane.

This Order comes into force on the 24th day of September, 2017.
