Regulations, 2017**

THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, in exercise of the powers conferred on it by sections 10 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990<sup>a</sup>, section 1 of the Health Service (Benefit) (Limited Lists) Ordinance, 2004<sup>b</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendment of the 2004 Regulations.**

1. In regulation 2B of the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) Regulations, 1990<sup>c</sup>, for "Health Service (Benefit) (Nurse Prescribers) Ordinance, 2013", substitute "Health Service (Benefit) (Approved Prescribers) Ordinance, 2017".

**Interpretation.**

2. (1) In these Regulations, unless the context requires otherwise –

"enactment" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation,

"subordinate legislation" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance, and

other expressions have the same meanings as in the Health Service (Benefit) (Guernsey) Law, 1990.

(2) The Interpretation (Guernsey) Law, 1948<sup>d</sup> applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a

**Citation and commencement.**

3. These Regulations may be cited as the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) (Amendment No. 3) Regulations, 2017 and shall come into force on the 1<sup>st</sup> November, 2017.

**EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

These Regulations amend the Health Service (Benefit) (Limited List) Regulations, 1990 to substitute, for the reference in regulation 2B of those Regulations to the definition of "nurse prescriber" in the Health Service (Benefit) (Nurse Prescribers) Ordinance, 2013, a reference to the definition of "nurse prescriber" in the Health Service (Benefit) (Approved Prescribers) Ordinance, 2017.

These Regulations come into force on the 1<sup>st</sup> November, 2017.
