THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred on it by paragraph 4(2) of Schedule 4 to, and section 66(2) of, the Data Protection (Bailiwick of Guernsey) Law, 2001<sup>a</sup>, and of all other powers enabling it and after consultation with the Data Protection Commissioner in accordance with section 66(3) of that Law, hereby makes the following order:-

**Amendment of the 2002 Order.**

1. In the definition of "the Stock Exchange" in article 2(3) (interpretation) of the Data Protection (Transfer in the Substantial Public Interest) Order, 2002<sup>b</sup>, for "the Channel Islands Securities Exchange Authority Limited" substitute "The International Stock Exchange Authority Limited (Guernsey company registration number 57527)".

2. The Data Protection (Transfer in the Substantial Public Interest) (Amendment) Order, 2015<sup>c</sup> is revoked.

**Interpretation.**

3. (1) The Interpretation (Guernsey) Law, 1948<sup>d</sup> applies to the interpretation of this Order.

(2) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

**Citation and commencement.**

4. This Order may be cited as the Data Protection (Transfer in the Substantial Public Interest) (Amendment) Order, 2017 and shall come into force on the 26<sup>th</sup> April, 2017.
