**The Fire Services (Fees and Charges) (Guernsey)
Regulations, 2016**

THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred on it by sections 1A(1), 12(4AB), 24(2A) and 26A of the Fire Services (Guernsey) Law, 1989^a hereby makes the following regulations:-

Fees and charges for equipment and services.

1. Schedule 1 prescribes the rate at which, and manner in which, the fee or charge for the provision of equipment and services by agreement between the Committee and another person under section 1A(1) of the Law is to be calculated.

Fees for notifications relating to controlled premises.

2. For the purposes of section 12(4AB) of the Law, Schedule 2 prescribes the fee which must accompany written notice of each event specified in section 12(4AA) of the Law, other than an event specified in section 12(4AA)(d) (premises ceasing to become controlled premises).

Charges for provision of Committee's views.

3. For the purposes of section 24(2A) of the Law, Schedule 3 prescribes the rate at which, and manner in which, the fee or charge payable to the Committee for providing its views upon being consulted by an Authority on an application of the kind specified in section 24(2) of the Law is to be calculated.

Interpretation.

4. (1) In these regulations, unless the context requires otherwise -

"**Authority**" has the meaning given by section 24(4) of the Law,

"**enactment**" means any Law, Ordinance or subordinate legislation,

"**the Law**" means the Fire Services (Guernsey) Law, 1989, and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect.

(2) Any reference in these regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended and applied.

Revocation.

5. The Fire Services (Fees and Charges) (Guernsey) Regulations, 2015^b are hereby revoked.

Transitional provisions relating to existing agreements for equipment or services.

6. (1) This regulation applies where –
- (a) before the commencement of these Regulations, the Committee has entered into an agreement with another person under section 1A(1) of the Law for the provision of specific equipment or service,
 - (b) the agreement specifies or refers to the rate, fee or charge prescribed for the equipment or service by the Fire Services (Fees and Charges) (Guernsey) Regulations, 2015, and
 - (c) the equipment or service is subsequently provided to the person in accordance with that agreement (whether before or after the commencement of these Regulations).

(2) Where this regulation applies, the fee or charge for the provision of that equipment or service is to be calculated at the rate and in the manner prescribed by the Fire Services (Fees and Charges) (Guernsey) Regulations, 2015.

- (3) Paragraph (2) has effect –
- (a) despite regulations 1 and 5, and
 - (b) as if the Fire Services (Fees and Charges) (Guernsey) Regulations, 2015 were still in force.

Transitional provisions relating to mandatory consultation.

7. (1) This regulation applies where –
- (a) an application of the kind specified in section 24(2) of the Law is made to an Authority before the commencement of these Regulations,
 - (b) the Authority is required to consult the Committee under section 24(2) before granting the application, and
 - (c) the Committee is so consulted (whether before or after the commencement of these Regulations).

(2) Where this regulation applies, the fee or charge payable to the Committee for providing its views upon being so consulted by the Authority is to be calculated at the rate and in the manner prescribed by the Fire Services (Fees and Charges) (Guernsey) Regulations, 2015.

- (3) Paragraph (2) has effect –
- (a) despite regulations 3 and 5, and
 - (b) as if the Fire Services (Fees and Charges) (Guernsey) Regulations, 2015 were still in force.

Citation.

8. These Regulations may be cited as the Fire Services (Fees and Charges) (Guernsey) Regulations, 2016.

Commencement.

9. These Regulations shall come into force on the 1st January, 2017.

Rates and abbreviations

Rates

- Band A = £100 per hour, for the professional services of CFO or DCFO.
Band B = £65 per hour, for the specialist services of HFS, HOO, DO or FSM.
Band C = £40 per hour, for the technical services of FSS, WC, CC, Instructor or FF.
Band D = £25 per hour, for administration services.

Testing of fire safety facilities – dry risers	Bands B, C and D as applicable, together with the applicable fee or charge for a Special Appliance.
Fire marshal training – standard course	£45 per person, minimum of 10 attendees
Fire marshal and fire extinguisher training – bespoke (Level 1)	£90 per person, minimum of 10 attendees.
Fire Safety Training for the Responsible Person (Level 2)	£115 per person, minimum of 5 attendees
Fire Safety Supervisory Training (Level 3)	£150 per person, minimum of 5 attendees
Fire Safety Risk Surveys as per the Regulatory Reform (Fire Safety) Order, 2005 (U.K.S.I. No. 1541 of 2005)	£600 per day. Charge includes administration and full written report.
Fire extinguisher training – standard water, CO2 and dry powder extinguishers	£45 per person, minimum of 10 attendees
Fire extinguisher training – other extinguishers	£45 per person plus cost of consumable materials.
Preliminary assessments and consultation on drafts of plans of premises proposed to be put to a designated use deposited with the Development & Planning Authority (as mentioned in section 24(1) of the Law), or on applications proposed to be	Bands A, B and D as applicable.

Bands A, B, C and D as applicable.
Any use of the services of staff of the Guernsey Fire & Rescue Service falling within section 1A(1)(b) or (c) of the Law, but not covered by any of the descriptions above.	Bands A, B, C and D as applicable.

These Regulations prescribe fees and charges for equipment and services provided by agreement with the Committee for Home Affairs (acting through the Guernsey Fire & Rescue Service) ("**the Committee**"), fees for notification of controlled premises, and charges in respect of mandatory consultation with the Committee.

These Regulations will come into force on the 1st January, 2017.
