## The Parking Places (Amendment) (No. 4) Order, 2017

*Made*

*7th December, 2017*

*Coming into operation*

*18th December, 2017*

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963<sup>a</sup>, hereby orders:-

### Amendments to 1991 Order.

1. The Parking Places Order, 1991<sup>b</sup> is amended as follows.
  
2. In Schedule 1 –
  - (a) in Part B, the entry relating to disc parking place No. DB18 is revoked,
  
  - (b) in Part C, immediately after the entry relating to disc parking place No. DC22, insert the following additional

entries –

"DC22a	Rue des Monts, St Sampson	The east side of the portion of the road between the junctions with Rue des Pointues Rocques and Mont Morin
DC22b	Bulwer Avenue, St Sampson	The west side of the portion of the road between its junctions with Rue Dorey and South Quay, within limits indicated by signs, but excluding Approved Parking Place No. AA30."

and

- (c) in Part D, in the entry relating to disc parking place No. DD16, for "AB15" substitute "AB15 and AC67a".

3. In Part A of Schedule 2 –

- (a) in the entry relating to approved parking place No. AA30, add at the end "within limits indicated by signs, but excluding Disc Parking Place No. DC22b",
- (b) the entry relating to approved parking place No. AA51 is revoked,
- (c) in the entry relating to approved parking place No.

AA57, for "and AC26" substitute ", AC26 and AC26a",

- (d) in the third column of the entry relating to approved parking place No. AA61, add at the end "but excluding Approved Parking Place Nos. AC11 and AC12", and
- (e) in the third column of the entry relating to approved parking place No. AA72, add at the end "but excluding Approved Parking Place No. AC5b".

4. In Part C of Schedule 2 –

- (a) immediately after the entry relating to approved parking place No. AC5a, insert the following additional entry –

"AC5b	Sandy Hook Estate, St Sampson	The portion of the north side of the road as near as may be to No. 12, within limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

- (b) the entries relating to Approved Parking Places Nos. AC5d, AC6a and AC6c are revoked,
- (c) immediately after the entry relating to approved parking place No. AC11, insert the following additional entry –

"AC12	Bas Courtils Estate, St Saviour's	The portion of the north side of the road opposite No. 10, within limits indicated by signs as being reserved for persons in possession of a disabled person's badge."
-------	--------------------------------------	--

- (d) immediately after the entry relating to approved parking place No. AC26, insert the following additional entry –

"AC26a	Rue Jehannet, St Martin's	The portion of the road as near as may be to No. 29, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

and

- (e) immediately after the entry relating to approved parking place No. AC67, insert the following additional entry –

"AC67a	Vauvert	The portion of the south side of the road as near as may be to Maple Place, within limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

**Interpretation.**

5. (1) In this Order, unless the context requires otherwise -

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation,

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance.

(2) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

6. This Order may be cited as the Parking Places (Amendment) (No. 4) Order, 2017 and shall come into force on the 18th December, 2017.

EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order amends the Parking Places Order, 1991. It creates four new disabled parking spaces, in Vauvert, Sandy Hook Estate, Bas Courtils Estate and the Rue Jehannet Estate, removes a disabled parking space from the Valnord Estate, and removes from the Order references to parking spaces in the former Grand Bouet Estate. It also replaces the 1 hour disc parking spaces at Rue des Monts, St Sampson's with 2 hour disc parking spaces; and ratifies two 2 hour parking spaces near Mont Crevelt House, Bulwer Avenue.

This Order comes into force on the 18th day of December, 2017.
