THE COMMITTEE for ECONOMIC DEVELOPMENT, in exercise of the powers conferred on it by section 17 of the Tourist Law, 1948^a as amended^b and all other powers enabling it in that behalf, hereby orders:-

Fee payable by applicants for a boarding permit.

1. An applicant for a boarding permit shall pay to the Committee on application for a permit valid from 1st April 2018 to 31st March 2019, or part thereof, a fee according to the type and nature of the premises within which the accommodation is to be provided:

- a) For visitor accommodation to be provided in premises described by the Committee as Hotel, Guest Accommodation or Self-Catering visitor accommodation, the sum of £8.50 per person inscribed on each application submitted.
- b) For visitor accommodation to be provided in any other type of premises, the sum of £50-00 per application submitted.

Interpretation.

2. (1) In this Order, unless the context requires otherwise ¥

(b) ±**Committee**≤ means the Committee *for* Economic Development.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Revocation

3. The Boarding Permit Fees Order (2), 2017^d is revoked.

Transitional Provisions

Citation.

4. This Order may be cited as the Boarding Permit Fees Order, 2018.

Commencement.

5. This Order comes into force on the 1st April, 2018.

The Boarding Permit Fees Order 2018

In pursuance of Section 17 of the Tourist Law, 1948, the Boarding Permit Fees Order, 2018, made by the Committee *for* Economic Development on 25th January 2018, is laid before the States.

EXPLANATORY NOTE

This Order prescribes the fees payable by an applicant for a boarding permit valid during the period 1st April 2018 to 31st March 2019 and replaces the Boarding Permit Fees Order (2), 2017.

The Order is to come into force on 1st April 2018
