

The Parking Places (Amendment) Order, 2018

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963^a, hereby orders:-

Amendments to 1991 Order.

1. The Parking Places Order, 1991^b is amended as follows.
2. In Part C of Schedule 1, in the third column of the entry relating to disc parking place No. DC4aa, for "October" substitute "September".
3. In Part A of Schedule 2 –
 - (a) in the third column of the entry relating to approved parking place No. AA19, for "Approved Parking Place No. AB19" substitute "Approved Parking Places Nos. AB19 and AC4",

- (b) in the third column of the entry relating to approved parking place No. AA71, add at the end "but excluding Approved Parking Places Nos. AC21 and AC21a",
- (c) immediately after the entry relating to approved parking place No. AA96, insert the following additional entry –

"AA97	Vale Castle Car Park, Vale	The south side of Castle Road within the limits indicated by signs."

4. In Part B of Schedule 2, in the third column of the entry relating to approved parking place No. AB19, for "AA14" substitute "AA19".

5. In Part C of Schedule 2 –

- (a) immediately after the entry relating to approved parking place No. AC3, insert the following additional entry –

"AC4	Maurepas Road	The portion of the north side of the road immediately to the west of its junction with Mont Arrive, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

- (b) in the third column of the entry relating to approved parking place No. AC12, for "No. 10" substitute "Nos. 10 and 11",

- (c) immediately after the entry relating to approved parking place No. AC20, insert the following additional entries –

"AC21	Le Bordage, St Sampson's	The portion of the south side of the road adjacent to No. 6 within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC21a	Le Bordage, St Sampson's	The portion of the south side of the road adjacent to No. 17 within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge."

Interpretation.

6. (1) In this Order, unless the context requires otherwise -

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation,

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation and commencement.

7. This Order may be cited as the Parking Places (Amendment) Order, 2018 and shall come into force on the 16th April, 2018

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Parking Places Order, 1991. It creates four new accessible parking spaces for holders of a blue badge in Maurepas Road in St Peter Port, Bas Courtils Estate in St Saviour's, and Le Bordage Estate in St Sampson's, in the existing

23-hour approved parking spaces. The Order also introduces a new 23-hour approved parking area at Castle Road, Vale and corrects two minor errors in the existing provisions relating to (a) the identification number of a parking area in Maurepas Road, and (b) the seasonal changes to parking at South Esplanade.

This Order comes into force on the 16th day of April, 2018.
