

The Control of Intoxicating Liquor (Designated Public Places) (Liberation Day) (No. 2) Order, 2018

4 May, 2018

Coming into operation

9 May, 2018

THE COMMITTEE FOR HOME AFFAIRS, in exercise of the powers conferred upon it by section 2(1) and (2) of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007^a, as amended, hereby orders:-

1. In order to prevent nuisance or annoyance to members of the public or a section of the public or disorder which is likely to be associated with the consumption of intoxicating liquor in that place -

- (a) the area of the Parish of St Peter Port marked in red on the attached plan, that is:-
 - (i) Salter Street, La Salerie Car Park and the QE2 Slipway,
 - (ii) Gategny Esplanade,
 - (iii) St Julian's Avenue to the junction with the Canichers,
 - (iv) North Beach Car Park,

- (v) The Weighbridge Roundabout, the North Esplanade, North Plantation, Le Tourgand, to its junction with Le Pollet, and the Quay to its junction with Church Hill,
- (vi) Le Truchot from the Weighbridge taxi rank to the junction with the Canichers,
- (vii) The Victoria Pier for its entire area, including the north and south arms of the Pier,
- (viii) The Albert Pier for its entire area but excluding the Red Light Arm,
- (ix) North Pier Steps from the Quay to the High Street,
- (x) Quay Steps from the Quay to North Pier Steps,
- (xi) the two Venelles located between Quay Steps and Quay Street from their junction with Quay to the High Street,
- (xii) Quay Street from its junction with the Quay to its junction with High Street,
- (xiii) Cow Lane from its junction with the Quay to its junction with Church Square,
- (xiv) the paved area to the seaward side of the Town Church to its junction with Church Hill to the south and its boundary with Church Square to its west,
- (xv) Le Pollet for its entire length from its junction with Le Truchot to its junction with High Street and Smith Street,
- (xvi) La Plaiderie from its junctions with Le Pollet to Sir William Place,
- (xvii) Smith Street from its junction with Le Pollet to Rue du Manoir,
- (xviii) The High Street from its junction with Le Pollet and Smith Street to its junction with Church Square,

- (xix) Berthelot Street,
- (xx) Lefebvre Street from its junction with the High Street to Rue de Manoir,
- (xxi) the entire area of Church Square, including Church Hill, Market Hill and the alleyway and steps leading from Church Square to the Commercial Arcade,
- (xxii) the whole of the Commercial Arcade,
- (xxiii) Fountain Street from its junction with Church Hill to the Bordage and Market Street,
- (xxiv) Market Street and Market Square from its junction with the Bordage and Fountain Street to its junctions with Church Square and Church Hill,
- (xxv) Le Petit Carrefour from the junction of Market Street and Fountain Street,
- (xxvi) the entire area covered by the Bus Terminus and the South Esplanade from its junction with the Quayside to its junction with the Castle Pier and Havelet,
- (xxvii) South Esplanade (The Albany) from the junction of Church Hill to Castle Emplacement, and
- (xxviii) Cornet Street from the junction with the South Esplanade up as far as the junction with Tower Hill and Cliff Street,

shall be a designated public place for the purpose of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007 between the hours of 10.00 a.m. and 12 midnight on the 9th May, 2018, and

- (b) the area of the Red Light Arm of Albert Pier shall be a

designated public place for the purpose of the Control of Intoxicating Liquor (Designated Public Places) Ordinance, 2007 between the hours of 10.00 a.m. and 5.00 p.m. on the 9th May, 2018.

2. The Control of Intoxicating Liquor (Designated Public Places) (Liberation Day) Order, 2018^b is hereby revoked.

3. This Order may be cited as the Control of Intoxicating Liquor (Designated Public Places) (Liberation Day) (No. 2) Order, 2018 and shall come into force on the 9th day of May, 2018.

EXPLANATORY NOTE


(This note is not part of the Order)

Explanatory Note

In order to prevent nuisance or annoyance to members of the public or a section of the public or disorder which is likely to be associated with the consumption of intoxicating liquor in that place, the area outlined in red on the plan shall be a designated public place for the purpose of the Ordinance at the times stated with the Order on 9th May 2018.
