The Alderney (Application of Legislation) ([Income Support]) Ordinance, 1972

THE STATES, in exercise of the powers conferred upon them by section one of the Alderney (Application of Legislation) Law, 1948^a, and of all other powers enabling them in that behalf, hereby order: –

Ordinance to have effect in Alderney.

1. The [Income Support] (Implementation) (Amendment) Ordinance, 1972^b, shall have effect in the Island of Alderney as it has effect in the Island of Guernsey.
