The Alderney (Application of Legislation) ([Income Support]) (No. 2) Ordinance, 1985

THE STATES, in pursuance of their Resolution of the 26th day of January, 1983, and in exercise of the powers conferred upon them by section 1 of the Alderney (Application of Legislation) Law, 1948^a, hereby order: –

Ordinance to have effect in Alderney.

1. The [Income Support] (Implementation) (Amendment) (No. 2) Ordinance, 1985^b, shall have effect in the Island of Alderney as it has effect in the Islands of Guernsey, Herm and Jethou.
