## **The [Alderney (Application of Legislation) (Income Support) (Amendment) Ordinance, 1995]**

**THE STATES**, in pursuance of their Resolution of the 26<sup>th</sup> day of July, 1995<sup>a</sup>, and in exercise of the powers conferred upon them by section 1 of the Alderney (Application of Legislation) Law, 1948<sup>b</sup>, as amended, hereby order: –

### **Amendment to Ordinance of 1971.**

1. In the [Alderney (Application of Legislation) (Income Support) Ordinance, 1971]<sup>c</sup>, in the left hand column of the First Schedule after the words "The [Income Support (Implementation) Ordinance, 1971]" insert "as amended from time to time".
