## **The [Alderney (Application of Legislation) (Income Support) (Amendment) Ordinance, 2014]**

**THE STATES**, in pursuance of their Resolution of the 7<sup>th</sup> March, 2012<sup>a</sup>, and in exercise of the powers conferred upon them by section 1 of the Alderney (Application of Legislation) Law, 1948<sup>b</sup>, and of all other powers enabling them in that behalf, hereby order: –

### **Amendment of Ordinance of 1971.**

1. The [Alderney (Application of Legislation) (Income Support) Ordinance, 1971]<sup>c</sup> is amended as follows.

2. In the left-hand column of the First Schedule, after the words "The [Income Support (Guernsey) Law, 1971]" insert "as amended by the [Income Support (Guernsey) (Amendment) Law, 2014]".

3. In the right-hand column of the First Schedule –

(a) at the beginning of the column insert –

"In section 1 immediately after "Guernsey", wherever appearing, insert "or Alderney".",

- (b) immediately after the entry relating to section 5(4)  
insert –

"In section 6B(1) for "Guernsey", wherever appearing  
substitute "Alderney".

In section 6B(2) –

- (1) for the definition of "a relevant person"  
substitute –

**"a relevant person"** means a person who is not  
ordinarily resident in Alderney", and

- (2) in the definition of "relevant circumstances" immediately after  
"Guernsey" insert "or Alderney".",

- (c) immediately after the entry relating to section 15,  
insert –

"In sections 15A and 15B immediately after "States",  
wherever appearing, insert "of Guernsey".",

- (d) for "Authority", wherever appearing, substitute  
"Department", and<sup>1</sup>

- (e) the entry relating to section 20 is deleted.

4. This Ordinance may be cited as the Alderney (Application of Legislation) (Income Support) (Amendment) Ordinance, 2014.]

5. This Ordinance shall come into force on the day that the [Income Support (Guernsey) (Amendment) Law, 2014] is registered on the Records of the Island.
