The [Income Support (Implementation) (Amendment) Ordinance, 2017]

THE STATES, in pursuance of their Resolution of the 8th November, 2017^a, and in exercise of the powers conferred on them by sections 3(2) and 15 of the [Income Support (Guernsey) Law, 1971]^b, and all other powers enabling them in that behalf, hereby order: –

Amendment of Ordinance.

1. (1) The [Income Support (Implementation) Ordinance, 1971]^c ("**the Ordinance**") is amended as follows.

2. For the numbered Tables set out in the appendix to the First Schedule to the Ordinance, substitute the numbered Tables set out in the Schedule to this Ordinance.¹

Interpretation.

3. (1) In this Ordinance –

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation,

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance.

(2) Any reference in this Ordinance to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Extent.

4. This Ordinance has effect in the islands of Guernsey, Alderney, Herm and Jethou.

5. This Ordinance may be cited as the Income Support (Implementation) (Amendment) Ordinance, 2017.]

6. This Ordinance shall come into force on the 5th January, 2018.
