



## The Parking Places (Amendment) (No. 2) Order, 2018

*Made*

*23rd August, 2018*

*Coming into operation*

*3rd September, 2018*

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963<sup>a</sup>, hereby orders:-

### Amendments to 1991 Order.

1. The Parking Places Order, 1991<sup>b</sup> is amended as follows.
2. In Part C of Schedule 1 –
  - (a) in the third column of the entry relating to disc parking place No. DC9, for "Nos. AB9 and Ab9a" substitute "AB9, AB9a and AB9b",
  - (b) in the third column of the entry relating to disc parking place No. DC14, add at the end "but excluding Approved Parking

Place No. AC30",

- (c) the entry relating to disc parking place No. DC18 is deleted,
- (d) in the third column of the entry relating to disc parking place No. DC21, for "the Fruit Export Company Limited" substitute "Vue de Vermerette".

3. In Part A of Schedule 2 –

- (a) in the third column of the entry relating to approved parking place No. AA14a, delete the words "but excluding approved parking place No. AB18b",
- (b) the entries relating to approved parking places Nos. AA73 and AA78 are deleted.

4. In Part B of Schedule 2 –

- (a) immediately after the entry relating to approved parking place No. AB9a, insert the following additional entry –

"AB9b	Le Bordage	In the off-street parking area that is on the south-east side of the portion of the road to the north-east of the junction with Pedvin Street, immediately to the east of Disc Parking Place No. DC9."

- (b) the entry relating to approved parking place No. AB18b is deleted.

5. In Part C of Schedule 2, immediately after the entry relating to disc parking place No. AC29, insert the following additional entry –

"AC30	Union Street	The portion of the north side of the road indicated by signs as being reserved for persons in possession of a disabled person's badge."

**Interpretation.**

6. (1) In this Order, unless the context requires otherwise -

"**enactment**" includes a Law, an Ordinance and any subordinate legislation and includes any provision or portion of a Law, an Ordinance or any subordinate legislation,

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any statutory, customary or inherent power and having legislative effect, but does not include an Ordinance.

(2) The Interpretation (Guernsey) Law, 1948<sup>c</sup> applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order amends the Parking Places Order, 1991. It creates one new accessible approved parking space for holders of a blue badge in Union Street in St Peter Port, and replaces a 2-hour disc parking space in the off-street parking area in Le Bordage, St Peter Port, with additional parking for motor cycles. The Order also removes references to parking spaces in the former Victoria Avenue flats area in St Sampson's, in Fountain Street and in Bosq Lane in St Peter Port, and removes a reference to a motorcycle parking space in St Jacques, St Peter Port. It also updates the reference to parking at Les Banques, St Peter Port.

This Order comes into force on the 3rd day of September, 2018.
