

The Water Charges (Amendment) Regulations, 2018

<i>Made</i>	16 th August, 2018
<i>Coming into operation</i>	1 st January, 2019
<i>Laid before the States</i>	2018

THE STATES' TRADING SUPERVISORY BOARD, in exercise of the powers conferred on it by section 17 of the Loi ayant rapport a la Fourniture d'Eau par les Etats de cette Ile aux Habitants de la dite Ile, 1927, as amended^a, sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^b and all other powers enabling it in that behalf, hereby make the following Regulations:-

Amendments to water charges for 2019.

1. For paragraphs 1, 2 and 4 of the Schedule to the Water Charges Ordinance 1991^c, as amended, substitute the following paragraphs –

"1. The charges which may be made under section 5 for a supply of water to a property by measure are –

- (a) a charge of £0.99 per cubic metre of water supplied, and
- (b) the quarterly charge in column 2 below appearing opposite the size shown in column 1 of the meter which measures the property's supply.

1. Size of meter	2. Quarterly charge
15 mm (½")	£14.09
20 mm (¾")	£28.19
25 mm (1")	£32.80
40 mm (1½")	£38.74
50 mm (2")	£41.83
75 mm (3")	£44.69
100 mm (4")	£50.60

2. The charge which may be made under section 4 or 6 for a supply of water for domestic purposes to a property otherwise than by measure is the quarterly charge in column 2 below and a quarterly charge of £0.28 multiplied by each assessable unit of the property as calculated for the purposes of property tax under the provisions of the Taxation of Real Property (Guernsey and Alderney) Ordinance, 2007^d.

1. Rate per assessable unit of TRP	2. Quarterly charge
£0.28	£14.09

4. (a) £66.57 (where the Board considers that the shutting-off or subsequent reconnection of the supply in question by the Board's employee has caused that employee to undertake duties outside his normal working hours).
- (b) £42.15 (in any other case).

Revocation.

2. The Water Charges (Amendment) Regulations, 2017^e are revoked

Interpretation.

3. (1) The Interpretation (Guernsey) Law, 1948^f applies to the interpretation of these Regulations.

- (2) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation.

4. These Regulations may be cited as the Water Charges (Amendment) Regulations, 2018.


Commencement.
