The [Income Support] (Implementation) (Amendment) Ordinance, 1988

THE STATES, in pursuance of their Resolutions of the 30th day of June, 1988 and 28th day of July, 1988, and in exercise of the powers conferred upon them by section 3(2) and section 15 of the [Income Support (Guernsey) Law, 1971]^a, hereby order: –

Amendment of Ordinance of 1971.

1. The [Income Support (Implementation) Ordinance, 1971], as amended^b, is hereby further amended as follows –

(a) section 3 thereof is hereby repealed and the following section is hereby substituted therefor –

" 3. (1) Where the weekly amount of [...] [income support] determined in accordance with the provisions of this Ordinance would be less than £1, the [income support] shall not be payable.

(2) Where the weekly amount of [...] [income support] determined in accordance with the provisions of this Ordinance exceeds £1, but is not a multiple of 25p, the amount by which it exceeds such a multiple shall, if it is 13p or more, be treated as 25p and, if it is 12p or less, be disregarded."

(b) paragraph 3(2) of Part I of the First Schedule thereto is hereby repealed and the following sub-paragraph is hereby substituted therefor –

" (2) For the purpose of the last preceding subparagraph the limit of the weekly income shall be £110.",¹

(c) paragraph 5 of Part II of the First Schedule thereto is hereby repealed and the following paragraph is hereby substituted therefor –

"Normal requirements

5. (1) The requirements of persons who are continuously in need of [...] [income support] for a period not exceeding 6 months shall be as follows that is to say –

(a) For a husband and wife or other persons falling within paragraph 2(1) of this schedule –

(i) where the applicant is aged sixty years or over ... £77.00

(ii) in any other case ... £74.00

(b) For a person living alone or a householder not falling within subparagraph (a) of this paragraph who is directly responsible for household necessities and rent (if any) –

(i) where that person is aged sixty years or over ... £48.00

(ii) in any other case ... £46.00

(c) For any other person –

- (i) where that person is aged sixty years or over ... £41.00
- (ii) aged eighteen years or over and who is not a person to whom item (i) of this sub-paragraph applies ... £38.00
- (iii) aged sixteen years or over but less than eighteen years . £27.00
- (iv) aged thirteen years or over but less than sixteen years ... £22.00
- (v) aged eleven years or over but less than thirteen years .. £16.00
- (vi) aged five years or over but less than eleven years ... £13.00
- (vii) aged less than five years £10.00.

(2) The requirements of persons to whom [...] [income support] has been payable for a continuous period of six months shall be as follows, that is to say –

- (a) For a husband and wife or other persons falling within paragraph 2(1) of this Schedule –
 - (i) where the applicant is aged sixty years or over ... £85.00
 - (ii) in any other case ... £82.00
- (b) For a person living alone or a

householder not falling within sub-paragraph (a) of this paragraph who is directly responsible for household necessities and rent (if any) –

- (i) where that person is aged sixty years or over ... £53.00
- (ii) in any other case ... £51.00
- (c) For any other person –
 - (i) where that person is aged sixty years or over ... £45.00
 - (ii) aged eighteen years or over and who is not a person to whom item (i) of this sub-paragraph applies ... £42.00
 - (iii) aged sixteen years or over but less than eighteen years . £30.00
 - (iv) aged thirteen years or over but less than sixteen years ... £23.00
 - (v) aged eleven years or over but less than thirteen years £18.00
 - (vi) aged five years or over but less than eleven years ... £14.00
 - (vii) aged less than five years £11.00." ²

the words "income support" in square brackets, wherever occurring, and the word omitted in square brackets immediately preceding those words, wherever occurring, were, respectively, substituted and repealed by the Income Support (Guernsey) Law, 2017, section 3(a) and section 3(b), with effect from 6th July, 2018.

Repeals.

2. Paragraph (a) and paragraph (b) of section 1 of the Supplementary Benefit (Implementation) (Amendment) Ordinance, 1987^c are hereby repealed.

Extent.

3. This Ordinance shall have effect in the Islands of Guernsey, Herm and Jethou.

Citation.

4. This Ordinance may be cited as the [Income Support] (Implementation) (Amendment) Ordinance, 1988.

5. This Ordinance and the [Income Support] (Implementation) Ordinances, 1971 to 1987, may be cited together as the [Income Support] (Implementation) Ordinances, 1971 to 1988.
