The Social Insurance (Rates of Contributions and Benefits, etc.) Ordinance, 2004

THE STATES, in pursuance of their Resolution of the 29th day of September, 2004^a and in exercise of the powers conferred upon them by sections 5, 6, 8, 17(2), 19, 48(2), 49(4), 50(1), 57, 60, 61, 62, 101 and 101A of the Social Insurance (Guernsey) Law, 1978, as amended^b and all other powers enabling them, hereby order: –

Percentage rates of primary and secondary Class 1 contributions.

In accordance with the provisions of the Social Insurance (Collection of Contributions) (Transfer of Functions) Regulations, 2018, regulation 1, with effect from 22nd October, 2018 and subject to the savings and transitional provisions in regulation 3, the functions, rights and liabilities of the Committee for Employment & Social Security and of its President and members relating to the collection of social insurance contributions arising under or by virtue of this Ordinance were transferred to and vested in, respectively, the Policy & Resources Committee and its President and members; and, in accordance with regulation 2 of the 2018 Regulations, for any reference herein to the Committee for Employment & Social Security or its President or members, however expressed, there was substituted, to the

extent that the reference related to the collection of social insurance contributions, a reference to the Policy & Resources Committee or (as the case may be) its President or members.

Upper weekly and upper monthly earnings limits.

Guernsey Health Service Fund Allocation and Long-term Care Insurance Fund Allocation.

The percentages determined in respect of the contribution year for the purposes of sections 101 (the Guernsey Health Service Fund Allocation) and 101A (the Long-term Care Insurance Fund Allocation) of the Law are those specified in columns 2 and 3 of the second schedule to this Ordinance of the aggregate amount paid in respect of each of the classes of contribution specified in column 1 of that schedule.

Interpretation.

Repeal.

9. (1) Sections 1 to 5 and 8 of and the Second Schedule to the Social Insurance (Rates of Contributions and Benefits, etc.) Ordinance, 2003^c are repealed with effect upon the coming into force of this section, namely, the 1st day of January, 2005.

(2) Section 6 of and the First Schedule to the Social Insurance (Rates of Contributions and Benefits, etc.) Ordinance, 2003 are repealed upon the coming into force of section 6 of this Ordinance, namely, the 3rd day of January 2005.

Extent.

10. This Ordinance shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation.

11. This Ordinance may be cited as the Social Insurance (Rates of Contributions and Benefits, etc.), Ordinance, 2004.

Commencement.

12. (1) Sections 1 to 5 and 7 to 12 of and the Second Schedule to this Ordinance shall come into force on the 1st day of January, 2005.

(2) Section 6 of and the First Schedule to this Ordinance shall come into force on the 3rd day of January, 2005.
