## **The Social Insurance (Rates of Contributions and Benefits, etc.) Ordinance, 2016**

**THE STATES**, in pursuance of their Resolutions of the 30<sup>th</sup> October, 2015<sup>a</sup> and the 3<sup>rd</sup> November, 2016<sup>b</sup>, and in exercise of the powers conferred upon them by sections 5, 5(1A), 6, 8, 19, 48(2), 49(4), 61, 101, 101A and 116 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>c</sup> and all other powers enabling them in that behalf, hereby order: –
