## The Environmental Pollution (Guernsey) (Amendment) Law, 2015 (Commencement) Order, 2018

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 27 of the Environmental Pollution (Guernsey) (Amendment) Law, 2015<sup>a</sup> and of all other powers enabling it in that behalf hereby orders:-

### Commencement of remaining provisions of the 2015 Law.

1. The following sections of the 2015 Law shall come into force on the 1<sup>st</sup> November, 2018<sup>b</sup> –

- (a) section 11, insofar as it inserts a new section 32A (charging for waste management services) into the Environmental Pollution (Guernsey) Law, 2004<sup>c</sup>, and

- (b) section 24 (amendment to the Competition (Guernsey) Ordinance, 2012).

**Interpretation.**

2. In this Order, "the 2015 Law" means the Environmental Pollution (Guernsey) (Amendment) Law, 2015.

**Citation.**

3. This Order may be cited as the Environmental Pollution (Guernsey) (Amendment) Law, 2015 (Commencement) Order, 2018.

EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order brings into force the remaining provisions of the Environmental Pollution (Guernsey) (Amendment) Law, 2015 (2015 Law) with effect from 1st November, 2018. Those provisions are section 11 of the 2015 Law insofar as it adds a new section

32A to the Environmental Pollution (Guernsey) Law, 2004 and section 24 which amends the Competition (Guernsey) Ordinance, 2012 (Competition Ordinance).

Section 32A gives the States power to make Ordinances in relation to charging for waste management services provided, managed, arranged, operated or funded by the Waste Disposal Authority. Section 24 amends the Competition Ordinance so as to provide an exemption from the provisions of that Ordinance in relation to specified matters in relation to Waste Disposal Authority waste tags and bags.
