**The Road Traffic (Speed Limits)
(Amendment) (No. 4) Regulations, 2018**

Made 20th November, 2018
Coming into operation 7th April, 2019
Laid before the States, 2019

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 2(2) and 8A of the Road Traffic (Speed Limits and Trials) Ordinance, 1987^a and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of Part I of Schedule 1 to the 1987 Ordinance.

1. In Part I of Schedule 1 to the Road Traffic (Speed Limits and Trials) Ordinance, 1987, in paragraph 3(h), after "La Route des Camps" delete "from the Queen's Hotel to its junction with La Grande Rue", after "Les Camps du Moulin" delete "from its junction with Rue de la Vallee to its junction with Ville Amphrey", and at the end of paragraph 3(h) insert –

"La Route de Sausmarez, from its junction with La Route des Camps to a point 45m north-east of its junction with La Route des Camps,

La Route de Blanchés, from its junction with La Route des Camps to a point 45m south east of its junction with La Route des Camps,

Old Mill Road,

Le Hurel,

Ville Amphrey,

Ruette Rabey,

La Rue des Frenes, from its junction with Longue Rue to a point 40m south-east of its junction with Longue Rue,

Les Merriennes, from its junction with La Grande Rue to 125m north of its junction with Rue de L'Eglise,

Les Traudes, from La Bellieuse to a point 100m north of its junction with Les Blanchés Pierres,

Rue de L'Eglise,

La Bellieuse,

La Vequesse, from its junction with La Grande Rue to a point 40m north east of its junction with La Grande Rue,".

Citation and commencement.

2. These Regulations may be cited as the Road Traffic (Speed Limits) (Amendment) (No.4) Regulations, 2018 and shall come into force on the 7th April, 2019.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations, one in a series of ten statutory instruments, have the effect of introducing a 25m.p.h. speed limit in the roads specified therein. These Regulations affect roads in St Martins.
