

**The Road Traffic (Speed Limits)  
(Amendment) (No. 7) Regulations, 2018**

**THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE**, in exercise of the powers conferred on it by section 2(2) and 8A of the Road Traffic (Speed Limits and Trials) Ordinance, 1987<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendment of Part I of Schedule 1 to the 1987 Ordinance.**

1. In Part I of Schedule 1 to the Road Traffic (Speed Limits and Trials) Ordinance, 1987 –

(a) at the end of paragraph 3(b) insert –

"Route Carre, from its junction with Les Petites Mielles to a point  
110m north of its junction with Braye du Valle,

Maladerie Road, from its junction with Les Petites Mielles to a point  
50m west of its junction with Les Petites Mielles,

La Marette Road, from its junction with Les Petites Mielles to a point 36m west of its junction with Les Petites Mielles,

Les Tracheries Road, from its junction with Les Petites Mielles to a point 66m west of its junction with Les Petites Mielles,

La Route de L'Islet, from its junction with La Route du Picquerel to a point 20m north-east of Sandy Lane,

Picquerel Road,

Les Petites Mielles,

Sandy Lane,

Sandy Hook, from its junction with Route Carre to a point 50m from its junction with La Route de L'Islet,"

(b) at the end of paragraph (e), insert –

"Route du Picquerel, from its junction with Les Petites Mielles to a point 10m south east of the Royal British Legion," and

(c) at the end of paragraph (f), insert –

"Le Picquerel,

Houmet Lane, from its junction with Route du Picquerel to a point 72m west of its junction with Route du Picquerel,".

**Citation and commencement.**

2. These Regulations may be cited as the Road Traffic (Speed Limits) (Amendment) (No.7) Regulations, 2018 and shall come into force on the 7<sup>th</sup> April, 2019.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations, one in a series of ten statutory instruments, have the effect of introducing a 25m.p.h. speed limit in the roads specified therein. These Regulations affect roads around L'Islet.

These Regulations come into force on the 7<sup>th</sup> day of April, 2019.
