



The Health Service (Medical Appliances) (Amendment) Regulations, 2018

THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, in exercise of the powers conferred on it by sections 18 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990^a, and of all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the 1990 Regulations.

1. The Health Service (Medical Appliances) Regulations, 1990^b are amended as follows.

2. For the Third Schedule to those Regulations, substitute the schedule set out in the Schedule to these Regulations.

Revocation of the 2017 Regulations.

3. The Health Service (Medical Appliances) (Amendment) Regulations, 2017^c are revoked.

Citation, commencement and extent.

4. (1) These Regulations may be cited as the Health Service (Medical Appliances) (Amendment) Regulations, 2018, and shall come into force on the 1st January, 2019.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations further amend the Health Service (Medical Appliances) Regulations, 1990, as amended, by increasing the charges payable to authorised appliance suppliers in Guernsey and Alderney by persons supplied with Part I, II or III medical appliances, who are not exempt from such charges. The increased charges amount to £4.00 for each appliance.

These Regulations come into force on the 1st day of January, 2019.
