


GUERNSEY STATUTORY INSTRUMENT

**The Social Insurance (Benefits) (Amendment)
Regulations, 2018**

THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, in exercise of the powers conferred upon it by sections 15, 20, 39 and 116 of the Social Insurance (Guernsey) Law, 1978^a, and of all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of the 2003 Regulations.

1. The five schedules to the Social Insurance (Benefits) Regulations, 2003^b are revoked and replaced by the five schedules set out in the Schedule to these Regulations.

Revocation of 2017 Regulations.

2. Regulation 3 of the Social Insurance (Benefits) (Amendment) Regulations, 2017^c is revoked.

Citation, commencement and extent.

3. (1) These Regulations may be cited as the Social Insurance (Benefits) (Amendment) Regulations, 2018, and shall come into force on the 7th January, 2019.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations replace the schedules to the Social Insurance (Benefits) Regulations, 2003, and prescribe the reduced rates of benefit payable from 7th January, 2019 to claimants who do not satisfy the conditions for entitlement to payment of the maximum rate of benefit.

These Regulations come into force on the 7th January, 2019.
