THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by sections 2A and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987^a, sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^b, sections 4, 5, 8, 9, and 16 of the Registration Marks (Sale and Retention) Ordinance, 1997^c, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment of 1932 Ordinance.

Sums prescribed under the 1997 Ordinance.

3. (1) For the purposes of the Registration Marks (Sale and Retention) Ordinance, 1997 ("the 1997 Ordinance"), the sums prescribed for the purposes of the section of the 1997 Ordinance named in the first column of the table below and described in the second column thereof, shall be the sum which appears in the corresponding third column of the said table –

Section 5	Sum prescribed for acquisition of right to reserve non-special registration mark	£88
Section 8(1) and 8(3)	Sum prescribed for issue of a duplicate copy	£44

(2) This Regulation shall be deemed to be an Order prescribed by the Committee for the Environment and Infrastructure under sections 4, 5, 8 and 9 of the 1997 Ordinance.

Amendment of 2007 Regulations.

4. For the Table of Fees in the Schedule to the Motor Taxation and Licensing (Fees) (Guernsey) Regulations, 2007^f, substitute the following table –

1. First registration of motor vehicle.	£44
2. Upon issue of duplicate certificate.	£14
3. Subsequent registration of motor vehicle.	£27.50
4. Upon issue of certificate of export.	£14"

Citation and commencement.

5. These Regulations may be cited as the Motor Vehicles, Licensing and Traffic (Fees) (Guernsey) Regulations, 2019 and shall come into force on the 1st March, 2019.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations increase the fees payable with effect from the 1st March, 2019 in relation to –

- the issue and renewal of driving licences and of duplicate licences
- first and subsequent registration of motor vehicles and the issue of duplicate registration certificates and certificates of export
- the exchange and retention of registration marks.

The increases are generally based on the increase in RPIX since the last review.

These Regulations come into force on the 1st day of March, 2019.
