THE BAILIFF OF GUERNSEY, in exercise of the powers conferred upon him by section 18(2) of the Court of Appeal (Guernsey) Law, 1961(a), hereby orders:-

Amendment of
Rules of 1964.

1. The Court of Appeal (Civil Division) (Costs and Fees) (Guernsey) Rules, 1964(b) (hereinafter called "the principal Rules") as amended(c), are hereby further amended as follows:-

- (a) in Rule 5(1) the words "forty new pence for each folio or part of a folio" are repealed and the words "^{five} ~~three~~ pounds for each foolscap page or part of a foolscap page" are substituted therefor;
- (b) in Rule 5(2) the words "twenty new pence for each folio or part of a folio" are repealed and the words "fifty pence for each foolscap page or part of a foolscap page" are substituted therefor;
- (c) the Schedule to the principal Rules is repealed and the Schedule set out in the Schedule to these Rules is substituted therefor.

Citation, 3.(1) These Rules may be cited as the Court of Appeal (Civil collective title and Division) (Costs and Fees) (Amendment) (Guernsey) Rules, commencement. 1985.

(2) These Rules and the principal Rules may be cited together as the Court of Appeal (Civil Division) (Costs and Fees) (Guernsey) Rules, 1964 and 1985.

(3) The Rules shall come into force on the 1st day of February, 1985.
