## **The European Union (Brexit) (Bailiwick of Guernsey) Ordinance, 2019**

## **The European Union (Brexit) (Bailiwick of Guernsey) Law, 2018 (Commencement) Ordinance, 2019**

THE STATES POLICY & RESOURCES COMMITTEE, in exercise of the powers conferred on the States by sections 11 and 15 of the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018<sup>a</sup> and all other powers enabling them in that behalf, and in exercise of the powers conferred on that Committee by Article 66A(1) of the Reform (Guernsey) Law, 1948<sup>b</sup>, hereby orders:-

### **Commencement of the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018.**

1. (1) The following provisions of the European Union (Brexit) (Bailiwick of Guernsey) Law, 2018 ("**the Law**") shall come into force on the 13<sup>th</sup> February, 2019 -

- (a) section 5 (Power to disapply, amend etc. Preserved EU law and other provisions), except paragraphs (a) and (b) of subsection (1),
- (b) section 9 (Provision in respect of the withdrawal agreement),
- (c) section 11 (General provisions as to Ordinances and regulations),

- (d) section 12 (Interpretation),
- (e) section 13 (Amendments to enactments and other consequential, transitional etc. provision), Schedule 1 and Schedule 2, but only to the extent necessary to bring the following paragraphs of Schedule 1 into effect-
  - (i) paragraph 3,
  - (ii) paragraph 4(1), insofar as it relates to paragraph 4(3), and
  - (iii) paragraph 4(3),
- (f) section 14 (Citation), and
- (g) section 15 (Commencement).

(2) The remaining provisions of the Law shall come into force on exit day, and for this purpose "exit day" has the meaning given by section 12(1) of the Law.

**Extent.**

- 2. This Ordinance has effect throughout the Bailiwick.

**Citation.**

- 3. This Ordinance may be cited as the European Union (Brexit)

(Bailiwick of Guernsey) Law, 2018 (Commencement) Ordinance, 2019.
