THE COMMITTEE FOR EMPLOYMENT & SOCIAL SECURITY, in exercise of the powers conferred on it by sections 10 and 35 of the Health Service (Benefit) (Guernsey) Law, 1990^a and section 1 of the Health Service (Benefit) (Limited Lists) Ordinance, 2004^b, and all other powers enabling it in that behalf, hereby makes the following Regulations:-

Amendment to the 2004 Regulations.

1. In the Schedule to the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) Regulations, 2004^c ("the Schedule") -

Citation, commencement and extent.

2. (1) These Regulations may be cited as the Health Service (Benefit) (Limited List) (Pharmaceutical Benefit) (Amendment No.2) Regulations, 2019, and shall come into force on the 8th day of May, 2019.

(2) These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.
