## **The Parking Places Order, 1991**

**THE STATES ISLAND TRAFFIC COMMITTEE**, in exercise of the powers conferred upon it by sections 1, 4A and 6A of the Road Traffic (Parking Places) Ordinance, 1963, as amended<sup>a</sup>, hereby orders: –

### **Article 1.**

1. The areas and parts specified in the third column of Schedule 1 of the public highways specified in the second column of that Schedule are designated disc parking places and are referred to in this Order by the numbers assigned to them in the first column of that Schedule.

### **Article 2.**

2. The areas and parts specified in the third column of Schedule 2 of the public highways specified in the second column of that Schedule are designated approved parking places and are referred to in this Order by the numbers assigned to them in the first column of that Schedule.

### **[Article 2A.**

2A. A person shall not, without the permission in writing of the Committee, park a vehicle or motor bicycle in any disc parking place or in any approved parking place except in accordance with any conditions indicated in respect of that disc parking place or approved parking place by signs and specified in the third column of the entry relating to that parking place in the relevant Schedule.]

**Article 3.**

3. A person shall not park a vehicle in any approved parking place in Part B of Schedule 2.

**Article 4.**

4. A person shall not park a motor bicycle in any disc parking place.

**Article 5.**

5. A person shall not park –

(a) a vehicle in any part of disc parking place [...] [DE31 or DE32], or

(b) ...

which, by order of the Harbour Master, is being used, or is required for use, in connection with any vessel.

**Article 6.**

6. A person shall not park a public vehicle in any disc parking place or approved parking place unless it is –

- (a) a bus parked in an approved parking place in Part E of Schedule 2, or
- (b) a taxi parked in an approved parking place in Part D of Schedule 2 for purposes of standing or plying for hire, or
- (c) a taxi parked on the west side of the area of the road comprised in approved parking place AD6 for no longer than 1 hour, or
- (d) a taxi or private hire motor car parked in a disc parking place, or in any approved parking place in Part A of Schedule 2, and not standing or plying for hire.

**Article 7.**

7. (1) A person shall not cause or permit a vehicle to be parked in a disc parking place or approved parking place in the course of a business of letting on hire, repairing or dealing in vehicles.

(2) A person shall not, without the permission in writing of the Committee, park a goods vehicle which weighs 1.5 tons or more unladen or is more than six feet wide in any disc parking place or approved parking place (except for loading or unloading) between 18.00 on any day and 08.00 on the next day following or on a Sunday or a Bank Holiday at any time.

**Article 8.**

8. (1) A person shall not, without the permission in writing of the Committee, park a motor bicycle or a vehicle in any approved parking place in Part D of Schedule 2 unless it is a taxi and (subject to Article 6(c)) is standing or plying for hire.

(2) A person shall not, without the permission in writing of the Committee, park a vehicle or a motor bicycle [...] on any part of a disc parking place or an approved parking place marked out by the Committee for loading or unloading, between 08.00 and 18.00 on any day except a Sunday or Bank Holiday (except for loading or unloading).

[ (2A) A person shall not, without the permission in writing of the Committee, park a motor vehicle or a motor bicycle in approved parking place [...] [AA23b or] AA81 between 08.00 and 18.00 on any day except a Saturday, Sunday or Bank Holiday other than in accordance with the conditions on the parking signs.]

[ (2B) A person shall not, without the permission in writing of [the Department] park a motor vehicle or a motor bicycle in Approved Parking Place No. AB22e between 1900 and 0800.]

[ (2C) A person shall not, without the permission in writing of [the Department], park a vehicle or a motor bicycle in Approved Parking Places Nos. AA85 and AA86 at any time except if displaying a valid Marine Traders permit in the vehicle issued by the Harbour Authority.]

(3) A person shall not, without the permission in writing of the Committee, park a motor bicycle or a vehicle other than a bus in any approved parking place in Part E of Schedule 2.

**Article 9.**

**9.** Subject to Article 13, a person shall not, without the permission in writing of the Committee, park a vehicle –

- (a) in any disc parking place in Part A of Schedule 1 for a continuous period greater than 30 minutes ending between 08.00 and 18.00,

- (b) in any disc parking place in Part B of Schedule 1 for a continuous period greater than 1 hour ending between 08.00 and 18.00,
- (c) in any disc parking place in Part C of Schedule 1 for a continuous period greater than 2 hours ending between 08.00 and 18.00,
- (d) in any disc parking place in Part D of Schedule 1 for a continuous period greater than 5 hours ending between 08.00 and 18.00,
- (e) in any disc parking place in Part E of Schedule 1 for a continuous period greater than 10 hours ending between 08.00 and 18.00,
- (f) ...
- (g) in any disc parking place in Part G of Schedule 1 –
  - (i) between 06.00 and 10.00 except, for a continuous period not greater than 30 minutes, for the purpose of delivering to or collecting from trade premises for trade purposes, or
  - (ii) for a continuous period greater than 30 minutes ending between 10.00 and 18.00,
- [(h) in any disc parking place in Part [H] of Schedule 1 –

*Consolidated text*

- (i) between 06.00 and 10.00 [on any day other than a Saturday, Sunday or Bank Holiday] except, for a continuous period not greater than 30 minutes, for the purpose of delivering to or collecting from trade premises for trade purposes, or
  - (ii) [ in disc parking places [DH2, DH3 or DH4]] for a continuous period greater than 1 hour ending between 10.00 and 18.00.
  - [(iii) in disc parking place DH1 for a continuous period greater than 2 hours ending between 10.00 and 18.00,]]
- [(i) in any Disc Parking Place in Part I of Schedule 1 –
- (i) between 07.00 and 09.00 on any day other than a Saturday, Sunday or Bank Holiday except for the purpose of delivering to or collecting from trade premises for trade purposes, or
  - (ii) for a continuous period greater than 30 minutes ending between 09.00 and 18.00,]
- [(j) in any Disc Parking Place in Part J of Schedule 1 –
- (i) between 08.00 and 10.00 on any day other than a Sunday or Bank Holiday except for the purpose of delivering to or collecting from trade premises for trade purposes, or

- (ii) for a continuous period greater than 30 minutes ending between 10.00 and 18.00.]

**Article 10.**

**10.** A person shall not, without the permission in writing of the Committee, park a vehicle or a motor bicycle in any approved parking place in Part A of Schedule 2 [...] for a continuous period greater than 23 hours.

**Article 11.**

**11.** A person shall not, without the permission in writing of the Committee, park a motor bicycle [or a motor bicycle combination or a motor tricycle] in any approved parking place in Part B of Schedule 2 [...] for a continuous period greater than 23 hours.

**Article 12.**

[ **12.** (1) Subject to paragraph (2), a person shall not, without the permission in writing of the Committee park a vehicle or motor bicycle in any approved parking place in Part C of Schedule 2 at any time, except for the purpose indicated in respect of that approved parking place by the signs referred to in the third column of that Part.

(2) Notwithstanding paragraph (1), a person may park a vehicle or motor bicycle in Approved Parking Place AC2 or AC2a between 07.00 and 10.00 or between 17.00 and 19.00 Monday to Saturday for the purpose of delivering to or collecting from trade premises in the vicinity thereof for trade purposes.]

**Article 13.**

**13.** Notwithstanding Article 9, a person may park a vehicle in any disc parking place for any length of time –

- (a) between 18.00 on a Saturday and 08.00 on the next following Monday, and/or
- (b) between 18.00 on the day preceding a Bank Holiday and 08.00 on the day after the Bank Holiday.

**Article 14.**

**14.** A person shall not park a vehicle or motor bicycle in any disc parking place or approved parking place except in the manner indicated by any parking signs and/or white lines marked by the Committee.

**Article 15.**

**15.** A person who parks a vehicle in a disc parking place or approved parking place must park it as close as is reasonably practicable to any other vehicle parked therein.

**Article 16.**

**16.** A person who parks a vehicle in a disc parking place or approved parking place for a single line of vehicles adjacent to a kerb or the edge of a carriageway must park it as close as is reasonably practicable to that kerb or the edge of that carriageway, as the case may be.

**Article 17.**

17. A person in charge of a vehicle or a motor bicycle which is parked in a disc parking place or approved parking place must move it within, or remove it from, that parking place on being requested to do so by any person having reasonable grounds for making such a request or by an officer of police.

**Article 18.**

18. A person in charge of a vehicle which has been parked in a disc parking place –

- (a) must remove that vehicle from that disc parking place before the expiry of the permitted period, and
- (b) must not, without the permission in writing of the Committee, re-park that vehicle in that disc parking place until a period of 30 minutes has expired.

**Article 19.**

19. (1) In this Order, unless the context otherwise requires –

**"numbers"** includes letters and numerals,

**"officer of police"** means a member of the salaried police force of the Island of Guernsey and, within the limits of his jurisdiction, a member of the special constabulary of the Island of Guernsey,

**"the Ordinance of 1986"** means the Public Transport Ordinance, 1986<sup>b</sup>,

**"private hire motor car"** means a vehicle in respect of which a private hire motor car licence is in force,

**"private hire motor car licence"** has the meaning assigned by section 57 of the Ordinance of 1986,

[ **"Public Holiday"** means a day approved as a Public Holiday by Ordinance,]

**"public service omnibus licence"** has the meaning assigned by section 57 of the Ordinance of 1986,
