Explanatory Note.

The [Carer's Allowance] (Amendment) Regulations, 1995

THE GUERNSEY SOCIAL SECURITY AUTHORITY, in exercise of the powers conferred upon it by section 2 of the [Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 1984]^a, hereby orders: –

Amendment.

1. In regulation 6 of the [Carer's Allowance (Guernsey) Regulations, 1986]^b the words following "earnings" are deleted and the following substituted –

"an amount equal to or greater than the lower earnings limit prescribed by Regulation 58(1) of the Social Insurance (Contributions) (Guernsey) Regulations^c."¹

NOTES

The words in square brackets in the title to these Regulations were substituted by the Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 2013, section 3(a)(ii), with effect from 1st May, 2014.

Extent.

2. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation.

3. These Regulations may be cited as the [Carer's Allowance] (Amendment) Regulations, 1995.

Commencement.

4. These Regulations shall come into force on the 6th day of November, 1995.

EXPLANATORY NOTE

*(This Note is not part of the Regulations, but is intended to indicate their general purport)^{**}*

These regulations increase the amount that can be earned before Carer's Allowance ceases to be payable from the earnings threshold, currently £30, to the lower earnings limit, currently £60 a week.
