The Water Charges (Amendment) Regulations, 2019

THE STATES' TRADING SUPERVISORY BOARD, in exercise of the powers conferred on it by section 17 of the Loi ayant rapport a la Fourniture d'Eau par les Etats de cette Ile aux Habitants de la dite Ile, 1927, as amended^a, sections 1 and 5 of the Fees, Charges and Penalties (Guernsey) Law, 2007^b and all other powers enabling it in that behalf, hereby make the following Regulations:-

Amendments to water charges for 2020.

1. For paragraph 4 of the Schedule to the Water Charges Ordinance 1991^c, as amended, substitute the following paragraph –

"4. (a) £67.97 (where the Board considers that the shutting-off or subsequent reconnection of the supply in question by the Board's employee has caused that employee to undertake duties outside his normal working hours).

(b) £43.04 (in any other case)."

Citation.

2. These Regulations may be cited as the Water Charges (Amendment) Regulations, 2019.

Commencement.

3. These Regulations shall come into force on the 1st January, 2020.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations increase the fees specified in paragraph 4 of the Schedule to the Water Charges Ordinance 1991 for reconnecting the supply of water to a property. These fees are regarded as charges under the Ordinance.

All other charges specified in the Schedule to the Ordinance (as amended by the Water Charges (Amendment) Regulations, 2018) remain unchanged.

These Regulations come into force on 1st January, 2020.
