ARRANGEMENT OF REGULATIONS

1. Warning to be given to persons supplied with Ethyl Petrol.
2. Supply from Pumps.
3. Penalty for infraction.

## **Ordonnance relative à la Vente de Pétrole dit "Ethyl Petrol"**

**LA COUR**, vu l'approbation des États, ouïes les conclusions des Officiers du Roi, a renouvelé comme Ordonnance permanente les dispositions de l'Ordonnance provisoire relative à la Vente de Pétrole dit "Ethyl Petrol", passée le 16 avril 1928, de laquelle Ordonnance la teneur suit: –

**ATTENDU QUE** le pétrole dit "Ethyl Petrol" est importé dans cette Île et est vendu pour l'usage des machines motives.

**ATTENDU QUE** des doutes existent si l'usage de tel pétrole est dangereux aux personnes qui s'en servent.

**ATTENDU QUE** le Gouvernement de Sa Majesté a nommé un Comité d'experts pour s'enquérir sur la matière mais le dit Comité n'a fait aucun rapport jusqu'à présent sur le sujet.

**ATTENDU QU'IL** est désirable de faire entretemps des règlements pour la protection du public.

**LA COUR**, ouïes les conclusions des Officiers du Roi, a adopté les règlements suivants rédigées en Anglais.

### **Warning to be given to persons supplied with Ethyl Petrol.**

**1.** No person shall sell or supply to any other person Ethyl petrol without informing him that he is supplying him with Ethyl petrol, and bringing to his notice the following warning, viz., –

"Ethyl" petrol contains "Ethyl" Fluid, and is to be used as a motor fuel only, it is not to be used for cleaning, washing or any other purpose; and spilling should be avoided. This recommendation should be strictly followed."

**Supply from Pumps.**

2. Ethyl petrol shall not be supplied from petrol pumps unless the words "Ethyl petrol" are painted in a conspicuous place in letters at least two inches high on such pump and the aforesaid warning printed in letters at least half an inch high is exposed on or in the immediate neighbourhood of such pump in a place where it can be easily read by the customer.

**Penalty for infraction.**

3. Any person who shall act in contravention of this Ordinance shall be liable to a penalty not exceeding [level 1 on the uniform scale].
