

The Boarding Permit Fees (2) Order, 2019

THE COMMITTEE for ECONOMIC DEVELOPMENT, in exercise of the powers conferred on it by section 17 of the Tourist Law, 1948^a as amended^b and all other powers enabling it in that behalf, hereby orders:-

Fee payable by applicants for a boarding permit.

1. An applicant for a boarding permit shall pay to the Committee on application for a permit valid from 1st April 2020 to 31st March 2021, or part thereof, a fee according to the type and nature of the premises within which the accommodation is to be provided:

- a) For visitor accommodation to be provided in premises described by the Committee as Hotel, Guest Accommodation or Self-Catering visitor accommodation, the sum of £8.50 per person inscribed on each application submitted.
- b) For visitor accommodation to be provided in any other type of premises, the sum of £50.00 per application submitted.

Interpretation.

2. (1) In this Order, unless the context requires otherwise –
 - (a) "the Law" means the Tourist Law, 1948; and

(b) "**Committe**" means the Committee *for* Economic Development.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of this Order.

(3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Revocation

3. The Boarding Permit Fees Order, 2019^d is revoked.

Transitional Provisions

Citation.

4. This Order may be cited as the Boarding Permit Fees (2) Order, 2019.

Commencement.

5. This Order comes into force on the 1st April, 2020.
